Walton Firs Activity Centre is an independent charitable organisation that delivers outdoor education programmes and residential services for young people aged between 5 and 18. Established in 2008, Walton Firs Activity Centre was awarded the 2020 Queen's Award for Voluntary Service in recognition of our longstanding commitment to young and community volunteers.

Alongside our reputation for high quality services, our close proximity to the A3 and M25 enables us to work with an extensive range of partners from across the south-east, with the vast majority returning to us year after year. Using our 35-acre woodland site in Cobham, we can provide more than thirty land-based outdoor activities and residential camping and accommodation facilities for Scouts, Guides, schools, and youth service providers.

During 2019/20 - our last year of pre-COVID opening - we delivered over 35,000 visitor days and 29,000 activity places, and engaged more than 18,000 children and young people in outdoor education activities, including 5,000 at risk of socio-economic disadvantage. We were supported by more than 70 volunteers to support the delivery and maintenance of our services, including 6 volunteer service crews.

### A Bit About the Job:

Walton Firs Activity Centre is staffed by a committed and growing team of staff. We've recently restructured our officers into four operational teams, including our Programmes Delivery Team, which is led by our acting operations manager / programmes manager. The team includes three full-time and permanently-contracted outdoor activities instructor posts, supported by a number of 'zero-hours' outdoor activities instructor posts. Our full-time activity instructor posts are contracted on a permanent basis, and offer year-round employment. We've chosen to not employ our instructors on seasonal basis, as we want to recruit, train, and retain the best quality employees for the long-term! For the chosen appointees, we will make significant investments in your professional development and give you opportunities to build your experience and achieve new qualifications.

Our outdoor activities instructor posts have two primary roles within the delivery of the activity centre's services. The first relates to the direct delivery of outdoor education programmes to young people, and the maintenance of our technical activity equipment and facilities. The second relates to the delivery of evening, weekend, and overnight customer support and site management accountabilities. The appointed postholders will need to be willing to work on a flexible basis, in response to service demands. Regular work patterns will include weekday evenings, weekends, and periodic public holiday periods, especially between March and October. We'll need you to hold a current and clear Enhanced DBS Certificate.

We're looking for enthusiastic, flexible, and 'young people-friendly' individuals who love working in outdoor settings, and who've been doing it for at least a year. Ideally, you'll be a qualified outdoor activities instructor, able to lead high ropes, archery, climbing, abseiling, bouldering, rifle shooting, bushcraft, and caving activity programmes, and will have a proven track record for delivering the highest standards of safety, service, and support to the customer. As well as these professional experiences and qualifications, you'll be willing and able to work flexible hours, including weekday evenings, weekends, and bank holidays. But even if you don't have all of the experience or qualifications listed above, if you have an ability to engage and support young people in outdoor activities, we'll welcome your application!

### 3. Outdoor Activity Facilities Maintenance:

- 3.1 To contribute to the planned inspections, maintenance, and cleaning of outdoor activity facilities and venues, ensuring compliance to all required health and safety standards and governing body-related requirements.
- 3.2 To contribute to the reactive maintenance, repairs, and cleaning of outdoor activity facilities and venues, ensuring compliance to all required health and safety standards and governing body-related requirements.

- 6.5 To support the development and maintenance of an 'accountability culture' within the activity centre, and ensure the effective management of the activity centre site, premises, facilities, equipment, and resources, as a member of the activity centre staff team.
- 6.6 To undertake any other duties or accountabilities commensurate with the grade of the post, as required to maintain effective public-facing services.
